____ Yes. I am participating purely for the joy of demonstrating, free of charge, and may or may not sell products. Items demonstrated/sold include:

- The Vendor Committee reserves the right to remove a booth from the Festival if the booth is constructed in an unsafe manner. Demonstrator booths and the area around them must be kept clean with all refuse, rubbish, and garbage deposited in containers provided.
- The Vendor Committee will provide each Demonstrator with one (1) vehicle pass/ID number that corresponds with their booth number. The pass allows entry of a vehicle through the barricaded boundaries of the Festival before and after hours of operation only. Please display the number in your vehicle on your dashboard throughout the event. All vehicles **must be parked** outside the barricades. Demonstrators will be provided with two (2) ID bracelets per booth which permits access to the Festival for both days. Additional passes are available by request.
- **Electric space heaters are NOT allowed** per the City of Winterset.
- Each booth **must have** a fire extinguisher.
- No generators will be allowed
- Only service and display animals **will be permitted** on Festival grounds. There are to be no pets inside the barricades. The Covered Bridge Festival is a no smoking/vaping event.

Demonstrators agree that it will protect, defend, hold harmless and indemnify the Chamber, Vendor Committee, and City of Winterset, their directors, officers, agents, employees, and volunteers from and against any and all expenses, claims, actions, liabilities, attorney fees, damages and losses of any kind whatsoever, actual or alleged, resulting from or concerned with the participation as a Demonstrator in the Festival. The Chamber, Vendor Committee, and the City of Winterset shall not be liable for any loss or damage to any merchandise or personal property in or about Demonstrator's booth(s) regardless of the cause of such loss or damage.
